

PUBLIC HEARING REGARDING PROPOSED ORDINANCE 9.11(1)(2) CHANGE TO ALLOW LIVE POULTRY & FOWL
WITHIN THE VILLAGE
MARCH 2021 KENDALL VILLAGE BOARD MEETING

Public Hearing called to order on March 8, 2021 at 5:15 pm by clerk J. Palamaruk.

- Motion by Wytttenbach, 2nd by Moten to nominate A. Keenan to chair the public hearing and monthly board meeting to follow. MC

Board members D Larson, A Keenan, M Prell, C Moten and L Wytttenbach were present with W Bunk and President R Martin Absent. Also present was Public Works Director Gruen and 3 visitors.

- Discussion on allowance of live poultry as follows:
 - L Hanson suggested the board look at each request on an individual basis taking location into consideration.
 - M Rauchele feels everyone should have an opportunity to own live poultry as long as there are no roosters and the birds are confined and not allowed to roam free.
 - J. Brown said he would like to see chickens in town.
 - L. Wytttenbach agrees with Hanson that the birds should be allowed on a case-by-case basis.
 - A Keenan said other municipalities allow poultry & fowl with a limit on the number allowed. D. Larson said most municipalities allow 3-5 birds per property.
 - C. Moten agrees with limiting the number of birds per property.
 - PW Director Gruen commended M Rauchele for doing the right thing by getting permission to have poultry before going forward with purchasing the birds.
- Motion by Wytttenbach, 2nd by Larson to close the public hearing. MC

The March board meeting of the Village of Kendall was brought to order March 8, 2021 at 5:30 pm by A Keenan along with board members D Larson, M Prell, C Moten and L Wytttenbach present with W Bunk and R Martin absent. Also present were Public Works Director Gruen, and 7 visitors.

- Motion made by Moten 2nd by Larson to accept the Feb meeting minutes. MC
- Motion made by Prell and 2nd by Wytttenbach to accept Feb Treasurer's report. MC
- Motion made by Prell and 2nd by Wytttenbach to accept Feb bills. MC
- Motion made by Larson 2nd by Moten to accept the Clerk's report. MC
- Public Works report was given.
- Motion made by Larson, 2nd by Moten to amend Ordinance 9.11(1) to allow poultry and other fowl within the village with the number allowed per property to be agreed upon based on the location of the property where the poultry and fowl will be kept with no roosters allowed and the birds must be kept in a confined area. MC
- Motion made by Wytttenbach, 2nd by Prell to rehire the 2 part-time summer helpers for public works from 2020. Wages will be discussed at the April 2021 board meeting. MC.
- An update regarding the village owned property at 215 Glendale road was given. Eagle Ridge Surveying completed a survey of the property which cost \$1500.00.
- An update regarding the FEMA buyout properties was given. Offers to Purchase have been sent out on 5 of the 6 properties.
- A park committee update was provided by A Keenan. The committee plans on meeting in April to discuss the location of a retaining wall & playground area and to establish a set of priorities.
- The board publicly thanked Pat Reibe for his \$250 donation towards a solar flag light for the Glendale Cemetery.
- Motion by Moten, 2nd by Wytttenbach to allow President R. Martin to speak with General Engineering Company (GEC) about providing building and electrical inspection services for the village. MC
- Motion made by Prell 2nd by Larson to allow the Royall Spin class to hold classes in the hall on Tuesday and Thursday evenings through mid-May until their room at the high school is available again. MC
- Motion made by Moten, 2nd by Larson to adjourn. MC.
