\*Lorraine Schnurr relatives, possible purchasers of trailer & realtor, with questions about village involvement with the placement of the trailer where it is now, causing problems as is over property line and owner won't sell or compromise. Board said they needed to talk more with owner as village cannot do anything.

\* Motion made by Bunk 2<sup>nd</sup> by Larson to approve a picnic license to the Fire Dept for a ballgame 9/30 and Cornbust on Labor Day weekend. MC

\* Motion made by Keenan 2<sup>nd</sup> by Larson to approve a picnic license to the Legion, Auxiliary, and Community Get Together for Labor Day weekend 9/1-2. MC

\*Jon Brown requested a variance for a carport to make it even with Kenview but the Board denied as they already gave him another driveway.
